Across 2 inspections since 2025, the issues cited most often were Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1), 591-1-1-.12(2) Requires That All Equipment and Furniture Be Free From Hazardous Conditions Such As, but Not Limited To, Sharp Rough Edges or Toxic Paint (1), and 591-1-1-.06(4) Requires a Center First Licensed After March 1, 1991, and Centers That Remodel or Add to Existing Plumbing Facilities, to Have the Bathroom Area Fully Enclosed and Ventilated to the Outside of the Building with Either an Open Screened Window or Functioning Exhaust Fan and Duct System and Requires Centers Without Fully Enclosed Bathrooms to Ensure There Is Adequate Ventilation to Con (1).
