Across 3 inspections since 2023, the issues cited most often were 591-1-1-.03(2) Requires the Center to Keep Current Lesson Plans on Site That Reflect Appropriate Instruction Practices and Activities to Support Children's Development The Center Shall Have Sufficient and Varied Play and Learning Equipment and Materials to Support the Above Program of Activities in All Developmental Areas. It Was Determined Based on Observation That Classroom A Did Not Have a Curr (1), 591-1-1-.25(3) Requires the Center and Surrounding Premises to Be Kept Clean, Free of Debris and in Good Repair. Hygienic Measures Such As, but Not Limited To, Screened Windows and Proper Waste Disposal Procedures Shall Be Utilized to Minimize the Presence of Rodents, Flies, Roaches and Other Vermin at the Center. It Was Determined That at Least Two Floor Tiles in Class B and C's Bathroom Were Cra (1), and 591-1-1-.36(7)(c)2. Requires That the Driver or Other Designated Person Shall Immediately Document in Writing, with a Check or Other Mark/symbol to Account for Each Child Listed on the Passenger Transportation Checklist Each Time a Child Enters and Exits the Vehicle. The Driver or Other Designated Staff Person Shall Document in Writing with a Different Mark/symbol to Account for Each Child Listed (1). None of the 5 findings were critical.
