Across 5 inspections since 2024, the issues cited most often were 591-1-1-.26(9) Requires the Playground to Be Kept Clean, Free From Litter and Free of Hazards, Such as but Not Limited to Rocks, Exposed Tree Roots and Exposed Sharp Edges of Concrete. It Was Determined Based on Observation That There Were Five Active Ant Beds to the Right of the Swing Set on Building 1 Playground That Posed a Potential Biting Hazard. (3), 591-1-1-.09(1)(a) Requires That a Center Ensure That Every Actual and Potential Director, Employee and Provisional Employee of a Child Care Learning Center Submit Both a Records Check Application to the Department and Fingerprints to an Authorized Fingerprinting Site. It Was Determined Based on a Review of Records That Staff #8 Hired on August 24, 2025, Did Not Have Evidence of a Valid and Current (1), and 591-1-1-.25(13) Requires That Potentially Hazardous Equipment, Materials and Supplies Be Stored in a Locked Area Inaccessible to Children. It Was Determined Based on Consultant's Observation That the Following Hazards Were Accessible on This Noted Date: -Room 1 - Broom and Dust Pan (1). None of the 5 findings were critical.
