Across 2 inspections since 2025, the issues cited most often were 591-1-1-.26(4) Requires That Playgrounds Be Protected From Traffic or Other Hazards by a (4) Four Foot High Fence or Other Barrier Approved by This Department. Fencing Material Shall Not Present a Hazard to Children and Shall Be Maintained So as to Prevent Children From Leaving the Playground Area by Any Means Other Than Through an Approved Access Route. Fence Gates Shall Be Kept Closed Except Whe (2), 591-1-1-.14(1)(a) Requires All Staff Who Provide Direct Care to Children Must Obtain Certification in a Biennial Training Program in Pediatric Cardiopulmonary Resuscitation (CPR) and a Triennial Training Program in Pediatric First Aid Within the First 45 Days of Employment. Current and Valid Evidence of the Successful Completion of Such Training Shall Be Maintained on the Center's Premises.
