Across 2 inspections since 2025, the issues cited most often were 290-2-3-.08(1) Requires the Home to Have a Current and Updated Record for Each Child in Care and for a Period of One (1) Year After Each Child Leaves. Such Records Shall Include: Identifying Information (Child's Name, Birth Date, Parent's Name, Home and Business Addresses, Telephone Numbers) (2) and 290-2-3-.07(10) Requires Evidence of Orientation and Training Shall Be Documented and Maintained in the Personnel File And/or Georgia's Workforce Registry and Professional Development System of Each Staff Member Which Shall Be Available to the Department for Inspection. Documentation Shall Include the Title of the Training Courses, the Dates, and the Number of Hours of the Courses, and the Names O (2). None of the 4 findings were critical.
