Across 4 inspections since 2024, the issues cited most often were Associated with Complaint 591-1-1-.32(7) Requires That Children Be Supervised at All Times Appropriate to the Individual Age, Needs and Capabilities of Each Child. Such Supervision Must Include, but Not Be Limited To, Indoor and Outdoor Activities, Mealtimes, Naptime, Transportation, Field Trips, and Transitions Between Activities. "Supervision" Means That the Appropriate Number of Staff Members A (1), 591-1-1-.09(1)(c) Requires the Center to Ensure That Every Employee Has a Valid and Current Satisfactory Comprehensive Records Check Determination on File Prior to Being Present at the Center While Any Child Is Present for Care or Before an Individual Age 17 or Older Resides in the Center.
