**Summary of Complaint:**

DHHS compliance staff received a concern that one of the providers left the childcare home. In this absence, the co-provider was left with 14 children. The reporter stated that the co-provider told reporter that the provider was in the basement. The provider did return to the home and came up the basement stairs. The reporter stated the provider told her that she had to move her vehicle.

Compliance staff completed an unannounced visit to the childcare home. During the visit, both providers were at the home. Discussion regarding the concern. The provider stated that her neighbor had a toy that she offered to the childcare. The provider was told that it was heavy. The provider stated that she did leave the childcare with her son to go and pick up this item. She showed compliance staff the home where she went. She stated that it was not heavy to them and they walked it to the basement door through the back yard.

**Rule Basis and Findings of Complaint(s):**

110.15(1) Specific requirements for child development home category C

e. If only one approved provider is present, not more than eight children are present.

**Resolution and Action Required:**

This is the second concern reported to DHHS in 2024 that the provider was not at the residence and the co-provider was at the home with more than eight children. Compliance staff discussed that the provider was not in a position to leave the childcare when there were more than eight children in care. A safety plan was created that addresses that one provider will not be left at the home with more than eight children. In the event that this situation occurs again in the future, a revocation of the registration will occur.

There is no amount of time that is allowable for one provider to have more than eight children in their care as a category C2 home. The providers are encouraged to secure a substitute who is able to come to the home if one of the providers cannot be at the home for any reason.
