(2), On 3/12 a Teacher Was Observed Using Inappropriate Discipline with a 5 Year Old Child. (1), and On 2/19/26 a Teacher Was Observed Using Inappropriate Discipline with a 3 Year Old child.A Teacher Was Reported for Pushing a Childs Head Down and Holding It. (1).
