Across 2 inspections since 2025, the issues cited most often were Items Labeled 'Keep Out of Reach of Children' Accessible as Follows: -Pathfinders Had Disinfecting Wipes on Top of a Filing Cabinet; -Voyagers Had Shaving Cream in an Unlocked Cabinet; -Men's Bathroom Had an Unlocked Storage Closet Containing Raid, Scrubbing Bubbles, Clean Freak, Degreaser, Sanitize (2), Children's Bathroom in Hallway Had a Mop Stored Inside. (1), and At Time of Visit, Nap Belongings Were Not Kept Separate in Sprouts and Weebles Rooms. (1). None of the 5 findings were critical.
