Across 2 inspections since 2025, the issues cited most often were Urinal in Boys Bathroom Appeared to Have a Leak, Making Wall Unable to Be Sanitized. Paper Towels Stored on Top Shelf Cannot Be Open to Air. (2), Previously Opened Food Items in Kitchen Were Not Labeled with Date Opened: Cereal, Toddler Formula. (1), and Items Labeled 'Keep Out of Reach of Children' Accessible as Follows: -Laundry Room with Hook and Eye Lock Had a Tub of Sunscreen and Laundry Detergent; -Miss Sadie's Room Had Shaving Cream Behind a Deterrent. (1). None of the 5 findings were critical.
