Across 2 inspections since 2025, the issues cited most often were Bathroom in Room 7 Had Peeling Paint on Wall. Bathroom in Room 8 Had Flooring That Appeared to Be Bubbled Up. Bathroom in Room 11 Had Standing Water on Floor Due to a Leaking Toilet and Second Bathroom Had a Crack in Flooring. (1), Items Labeled 'Keep Out of Reach of Children' Were Accessible in Room 7/School Age: Quat, Bleach, Resolve in an Unlocked Upper Cabinet. (1), and Room 3 Had a Step Stool Stored on Top of the Diapering Pad. (1). None of the 5 findings were critical.

● **Room 3 Had a Step Stool Stored on Top of the Diapering Pad.**

Caregivers shall use the diapering surface exclusively for diaper changing

● **At Time of Visit, Freezer in Kitchen Was Reading at 50 Degrees on One Thermometer and 55 Degrees on Another Thermometer.**

Correct food temperature and holding time shall be maintained for all food serve

● **Items Labeled 'Keep Out of Reach of Children' Were Accessible as Follows: -Rooms 3, 6, 7, 8, 10, and 11 Had Diaper Wipes. -Room 6 Had Desitin and A&D Ointment in a Stacker in the Bathroom.**
