- 5 Important

Across 3 inspections since 2024, the issues cited most often were At the Time of Arrival, One Staff Was Outside with 7 Children. Another Staff Was Inside with 1 Sick Child. With the Ages Present, the Ratio Needed Was 6:1. By the End of the Visit, Some Sick Children Left. By the End of the Visit Ratio Was Okay. (2), Licensee Needs a TB Result on File (1), and A Present Staff Member Does Not Have Consents for This Childcare. The Worker Does Have Them for a Different Center, but a Consent Must Be Done for Each Seperate Childcare the Staff Works At. A Staff Member Is Not "Qualified" Without Consents. (1). None of the 5 findings were critical.
