Across 1 inspection since 2024, the issues cited most often were Two Staff with Expired Fingerprints on File with the Division. (1), A Provider Shall Provide for a Safe Environment by Ensuring That No Conditions Exist in or on the Grounds of the Facility Where a Provider Operates a Child Care Program That Would Endanger the Health, Safety, or Welfare of the Children, Including Ensuring That the Following Items Are Placed in Areas (1), and On the Playground, Sitting Water in a Trash Can Lid Under Debris, Which Is a Safety Hazard. Fence Boards Are Broken. On the Side of the Church, Grill Parts Were Found Which Is Unsafe Within Reach of Children. At Time of Inspection, a Broken Rocking Horse Was Observed, Handles Are Missing, the Plas (1). None of the 5 findings were critical.
