Across 2 inspections since 2025, the issues cited most often were Regarding 3.19.26, Two Caregivers Left Gym Leaving Remaining Children in Gym Child/staff Ratio 8:0. (2), Regarding 3.19.26, Two Caregivers Left Gym, Remaining Children in Gym Not Under the Direct Supervision of a Responsible Caregiver at All Times. (1), and Regarding 3.19.26, Caregiver Swatted and Grabbed at 4 Year Old Boy Multiple Times, Used Her Body and Pushed Same Child Against Wall, Then Dragged Him Across Gym Floor by His Arm. (1). None of the 5 findings were critical.
