Across 2 inspections since 2025, the issues cited most often were Items Labeled 'Keep Out of Reach of Children' Were Accessible as Follows: -Orange Room Had Diaper Wipes in an Unlocked Drawer and Bic Wite-Out in Unlocked Teacher Desk Drawer; -Purple Room Had Diaper Rash Ointment on Shelf Under Unlocked Changing Table; -Gold Square Room Had Hand Sanitizer on Top Of (2), At Time of Visit Four (4) Staff Working with Children Had Expired Fingerprints. (1), and Bathroom in Orange Room Had a Plunger, and Shoes and Diapers Open to Air. Yellow Bathroom Had a Broom and a Dustpan. (1). None of the 5 findings were critical.
