Across 2 inspections since 2023, the issues cited most often were The Present Staff Member Has a Drug Screen That Does Not Have the MRO Requirements. All Drug Screens Must Have MRO Information on the Results. (1), With the Present Staff Not Having a Background Check Complete via a Consent Form, This Staff Does Not Count in Ratio. (1), and Present Staff Has Fingerprints Dated 5/25/2024. However, These Are Not Valid Without a Consent Form. This Staff Member Must Submit a Consent Form to Be Considered a Qualified Staff Member. (1). None of the 5 findings were critical.
