Items That Say "Keep Out of the Reach of Children" Must Be Inaccessible to the Children. (1), In the Toddler Bathroom, There Were Clothes on the Floor and Also in a Container Without a Lid. All Items Must Be Sanitizable in Restroom. (1), and On 7-15-25 a Staff Member Left a Student by Themselves in a Classroom Resulting in a Ratio of 1 Student to 0 Teachers. (1). None of the 5 findings were critical.
