(1), At Today's Visit, a Child Who Is 8mo Was Alseep in a Crib with a Quilt Pad Underneath Him. This Pad Was Not the Mattress Cover, but Extra Soft Bedding. Nothing Extra(blanket, Bottles, Bumpers, Etc) Can Be in a Pack and Play/crib with a Infant Under 12 Months. Pad Was Moved When Noted. (1), and At Today's Visit There Were 3 Separate Safe Sleep Non-compliances Viewed. One 11 Month Old Was Asleep in a Crib with a Bottle. The Second Child Was 6 Month Old and Was Asleep in a Car Seat with a Blanket Covering It. The Car Seat Was in a Crib. The Third Child Was Said to Be 5 Months Old, He Was Als (1). None of the 5 findings were critical.
