Across 2 inspections since 2024, the issues cited most often were Provider Is Unable to Adequately Check for Required Criminal History of Two Caregivers Without a Consent Form Permitting the Division to Send a Report to a Ministry. One Caregiver Has Not Submitted Fingerprints as Required for a Criminal Background Check. (2), One Caregiver Missing Current First Aid Training. (1), and Provider Has Not Submitted Consent for Child Abuse/neglect Check Without Substantiation on Two Staff Members (Consent), with One Submitted but Not Qualified at Time of Inspection. (1). None of the 5 findings were critical.
