Across 3 inspections since 2025, the issues cited most often were Child Was Fed Wheat Bread Which Was on His Allergy List. (1), In the Infant Classroom, Hazardous Items Such as Shaving Cream, Disinfectant Spray, Etc Were Accessible to Children. All Items That State Keep Out of Reach of Children, Must Be Kept Out of Reach of Children or Behind a Lock and Key. Staff Purse Was Also Under the Cabinet and Must Be Out of Reach O (1), and When Consultants Entered the Infant Room, a Child Was Awake in a Crib with the Mattress at Its Highest/sides at Their Shortest Height.
