(2), On 2/24 and 2/25/2026 a Staff Member Can Be Seen on Video Using Excessive Force with Three (3) Different 3-year Old Children, Pulling by Arms, Roughly Sitting Child Down in Chair, Intimidating, Roughly Pulling Child Across the Floor From Underneath a Table. Staff Person Was Terminated 2/26/2026. (1), and On 1/29/2026 Staff Member Paulina Walters Left a Three Year Old Female Child Alone in the Classroom for Approximately Nine (9) Minutes. Teacher Took Class to Playground, but One (1) Child Remained Behind in Classroom Unsupervised and with a Ratio of 0:1. Another Staff Member Walked by Classroom And (1). None of the 5 findings were critical.
