Children Must Be Within Sight or Sound at All Times. The Licensee Had Since Modified the House by Removing a Wall to Increase Visability. (1), and The Childcare Did Not Immediately Contact (Within 24hours) CPS or Law Enforcement Agency (LEA). A CPS Report Was Made on 7/1/2024. However, Licensing and CPS/LEA Must Both Be Notified Immediately. (1). None of the 5 findings were critical.
