Across 1 inspection since 2026, the issues cited most often were A Provider That Cares for More Than Sixteen (16) Children at a Facility Where the Provider Operates a Child Care Program Shall Maintain a Ratio of Children to Caregivers in the Same Proportions as Specified in the Child to Staff Ratio Requirements. (1), Each Childcare Provider, Household Member, Employee, Volunteer Caregiver Shall Submit Fingerprints for a National Criminal History Background Check by the FBI or Each Childcare Provider Has Local Criminal Check with Documentation That National Check Is Applied For. (1), and Bathroom in Friendly Frogs Had Clothes and Packs of Diapers Stored in a Basket Beside Diapering Table and a Child's Sweatshirt on Top of Diapering Table; Lions Had a Broom and Dustpan Stored in Bathroom. Bathroom in Preschool 2 Had Open Shelves with Towels and Diapers Stored. (1). None of the 5 findings were critical.
