The Facility Will Now Start Offering Milk to All Children Present for Meals. (1), and The Facility Did Not Have Staffing Patterns Posted with the Newly Hired Staff. The Facility Updated and Posted the Staffing Patterns Prior to the Inspection Ending Today. (1). None of the 5 findings were critical.
