(3), The Provider Did Not Notify the Office That the Substitute, Who Is Also a Resident of the Home, Had Pending Criminal Charges. The Provider Stated She Forgot to Notify the Office Because Something Like That Never Happened to Her. (2), and Licensing Specialist Observed a 9 Month Old Infant Sleeping on a Thick Blanket in a Pack and Play. The Infant Was Covered with Another Thick Blanket.
