(3), Licensing Specialist Observed a Substitute Aide Did Not Sign in on a Sub Log in Room 6 and a Substitute Teacher Did Not Sign in on a Sub Log in Room B. Corrected on Site When Both Substitutes Signed in on Sub Logs. (2), and Licensing Specialist Observed 7 Toddlers in Room 6 and Room 6 Is a Two's Room. Corrected on Site When Were Moved to Rooms 5 and 4. Licensing Specialist Observed Two 2 Year Old Children with One 3 Year Old Child in Room A and Two 2 Year Old Children in Room B and These Rooms Are Approved for Preschoo (2). None of the 14 findings were critical.
