Across 3 inspections since 2025, the issues cited most often were Two Teachers Did Not Complete 12 Hours of Continued Training. One Teacher Did Not Complete 2025 Basic Health and Safety Training. (2), LS Did Not Observe a Medical for HA, SAP, KC, SD, CM and UW - 5 Total (2), and The Walls and Floors in Most Classrooms Need to Be Cleaned. Food, Dirt, and Children's Markings Were Observed on Walls. The Floors Are Dusty Around the Edges, Rugs Need to Be Vacuumed, and Residue Is Built Up Under Gates. (1). None of the 13 findings were critical.
