Across 2 inspections since 2023, the issues cited most often were Non-compliance Was Noted Regarding Continuing Training Requirements for Aide MM. Aide MM Was Required to Complete 6 Hours of Continuing Training by 8/31/24 but Has Completed 0 Hours. (3), Non-compliance Was Noted Regarding Continuing Training Requirements for Teacher CH. Teacher CH Was Required to Complete 12 Hours of Continuing Training by 7/31/24 but Has Only Completed 1.5 Hours. (2), and Child in Care (L.W) Does Not Have a Documented Lead Screening. The Director Stated That She Has Had the Lead Test Done and Is Just Waiting on the Results to Be Documented. (1). None of the 7 findings were critical.
