Program Stated They Reviewed Camera Footage to Determine the Cause of the Mark on KM. (3), LS Observed a Fridge in Kitchen Without a Thermometer. Fridge in Room 1 Toddler/Two Observed with Fridge Temp of 48 Degrees. (2), and LS Observed School Age Teacher A. Harris in Charge of Infants in Room 2, Aide E. Diggs in Charge of Twos in Room 3, and Aide D. Lundy in Charge of Preschool Children in Room 5. According to K. McCormick They Were Substitutes for Today, but Their Names Were Not Listed on Substitute Logs with Today's (2). None of the 12 findings were critical.
