Assistant Director Went Into the Classroom to Correct at the Time of Inspection. Facility to Submit Staffing Pattern Showing Qualified Staff in Each Classroom. Aide in the Classroom Has Been Cleared Through MSDE. (1), and LS Observed a Qualified Aide Only in Charge of 6 Two Year Old Children. Assistant Director Entered the Classroom for the Day in Order to Meet the Regulation. Corrected at the Time of Inspection. Facility to Submit a Staffing Pattern Showing Qualified Staff in the Classroom at All Times. (1). None of the 6 findings were critical.
