Across 4 inspections since 2023, the issues cited most often were Facility Did Not Ensure the Safety and Security of Each Child at All Times. (2), Facility Did Not Maintain Procedures to Ensure the Whereabouts of Each Child in Attendance Is Known at All Times. (1), and The Facility Did Not Maintain in Incident Report for the Child. Staff Noticed Swelling on the Child's Foot and Did Not Write a Report Stated This. (1). None of the 13 findings were critical.
