Licensing Specialist Also Observed an Emergency Form Missing an Authorized Pick-up Person Listed. (3), Provider States That Her Son Was Not a Resident of the Home at the Time in Question. The Individual Moved Into the Home in 2022 and the Provider Did Not Notify the Office of a Criminal Charge. (2), and Licensing Specialist Did Not Observe Current Criminal Background Checks for Any Associated Party 18 Years Old and Older.
