Across 2 inspections since 2023, the issues cited most often were Licensing Specialist Confirmed That a Three Year Old Child Was Missing for Over 20 Minutes Outside of the Facility and Was Left Unsupervised, Indicating That Their Individual Supervision Needs Were Not Being Met at the Time of the Incident. (2), Specialists Observed a Damaged Tarp Near the Swings That Could Post an Entrapment Risk to Children in Care. (2), and Licensing Specialist Confirmed That a Child Was Left Unattended, Unsupervised, and Neglected to the Point That They Were Able to Travel Two Blocks Away From the Center Where They Could Be Subject to Harm. (1). None of the 5 findings were critical.
