Evidence of Lead Testing or an Appointment to Obtain a Lead Test Must Be Immediately Submitted by the Provider. LS Observed One Form with the Parent's Religious Objection That Was Not Verified via Signature and Date by the C (1), and LS Did Not Observe Evidence of a Health Assessment for Each Child.
