Staff Informed Licensing Specialist That a Report Was Provided to Child Protective Services. CPS Declined to Acknowledge Whether a Referral Came From the YMCA. (1), and On the Date of the Complaint Investigation Aides Were Assigned to the Group. On the Date of the Incident, Aides Were Assigned to the Group.
