(2), and LS Observed an Employee LS Alone with Children That Has Not Been Cleared by the Office of Child Care. LS Did Receive a Release of Information for This Employee However LS Never Received Cleared Fingerprints, Director Stated That She Was a Transfer From Another KinderCare in PG County. (2). None of the 11 findings were critical.
