(3), The Family Care Safety Registry Check Was Not Conducted for Belinda Raines, Kelly Raines, Tyesha Randle and Tracy Tankard Within Thirty (30) Days Prior to the Anniversary Date. (1), and The Facility Did Not Have a Fenced Outdoor Play Area That Was on or Adjoining the Day Care Property and Was Accessible Without Hazard as Evidenced by the Height of the Fence Was Less Than 42 Inches High - the Measured Height Was 38 Inches in 1 Area of the Fence That Was Approximately 5 -6 Feet Long.
