(2), Requirements for Immunization Reports on File Were Not Met as Evidenced by an Immunization Record Was Not on File the First Day a Child Attended and There Was No Exemption on File. (1), and Requirements of 19 CSR 30-60.080 Fire Safety Were Not Met as Evidenced by the Date And/or Type of Drill Were Not Recorded. (1). None of the 5 findings were critical.
