Across 1 inspection since 2025, the issues cited most often were Medical Examination Reports Including TB Testing Were Not on File for Caregivers as Evidenced by the Medical Form Did Not Contain All Required Information in That the Conclusive Statement Was Missing. (2), Requirements for Indoor Play Equipment and Materials Were Not Met. Feeding Equipment Was Not in Good Condition as Evidenced by Safety Straps Were Missing on the Feeding Table. (1), and The Facility's Outdoor Space Was Not Safe for Children's Activities as Evidenced by the Presence of the Black Plastic Ground Cover Is Exposed Creating a Tripping Hazard. (1).
