Across 1 inspection since 2026, the issues cited most often were Children Were Not Restricted to Approved Space as Evidenced by the Laundry Room Doors Were Unlocked and Children Have Access to Get Inide. (3), Furniture/equipment, Brown Couch, in the Koalas Room in the Back Left Corner Was Not in Good Condition as Evidenced by the Couch Had Tears and Rips in It and Thin Places in the Leather Which You Could See and Touch the Stuffing in the Couch. (1), and The Director Was Not Approved as Evidenced by They Do Not Have a Current Director. The Director Left in October 2025 and a New Director Has Been Hired to Start in January 2026. (1). None of the 5 findings were critical.
