Exposed Tree Routs in Play Yard Creating Tripping Hazards. (3), Outdoor Equipment, Allegator Teeter Tatter and Rocking Horses, in Play Yard Was Not in Good Condition as Evidenced by Missing Handle Bars. (1), and The Provider Does Not Have an Assistant Available. (1). None of the 5 findings were critical.
