Program Administration Violations Cited

1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towels for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

Plan of Correction

1. **POC:** The urinal in the boys restroom is not repaired. The plan of correction was not followed. Designee stated she would communicate with the owner regarding the corrections. Technical assistance provided: Rule 1.4.8 Prevention of Shaken Baby Syndrome and Abusive Head Trauma Rule: 1.4.9 Emergency Preparedness and Evacuation Planning. The director was provided with a reference guide via email to assist with completing the policy and procedures. The director was encouraged to review the reference to ensure all required policies and procedures are properly completed in accordance with regulations. The director will develop a plan and policy which will be maintained in a binder, and completed by May 31, 2026.
