There was no documentation of the NC Child Care Law given to one parent. Violation confirmed corrected by letter received from provider on 4/28/2026
- **All Vehicles Used to Transport Children Were Not Free of Hazards.**
The van used to transport the children did not pass the penny test meeting the required tread. The vehicle should be free hazards such as tire treads of less than 2/32 of an inch. Violation confirmed corrected by letter
- **A Copy of the Prevention of Shaken Baby and Abusive Head Trauma Policy Was Not Given to or Explained to Parents of Newly Enrolled Children Up to Five Years Of...**
