Across 2 inspections since 2023, the issues cited most often were Menus for All Meals and Snacks Were Not Current or Posted Where Easily Seen by Parents and Cook. (1), Monthly Playground Inspections Were Not Completed And/or They Were Not Completed by an Individual Trained in Playground Safety Requirements. (1), and NC Pre-K Program Staff/child Ratios and Group Sizes Were Not Met. (1). None of the 5 findings were critical.

● **Menus for All Meals and Snacks Were Not Current or Posted Where Easily Seen by Parents and Cook.**

A current menu was not posted in classroom # 313. The most recent menu posted was dated January 2025. Violation confirmed corrected by letter received from provider on 4/7/2025

● **Monthly Playground Inspections Were Not Completed And/or They Were Not Completed by an Individual Trained in Playground Safety Requirements.**

The last documented outdoor playground inspection was 10-4-24. Violation confirmed corrected by letter received from provider on 4/7/2025

● **NC Pre-K Program Staff/child Ratios and Group Sizes Were Not Met.**

A staff member was observed leaving classroom #313 for an estimated period of five minutes leaving one staff member with six-four year old children and six-five year old children. Violation corrected during visit

● **A Summary of the NC Child Care Law Was Not Given to a Parent of Every Child Enrolled in the Center.**
