- **All Staff Did Not Successfully Complete Certification in First Aid Appropriate to the Age of Children in Care.**
Verification of staff completion of First Aid training from an approved training organization was not in the staff file. One staff member did not have an approved first aid t
- **The Depth of the Loose Surfacing Was Not Based on Critical Height of the Equipment.**
The mulch was one inch in areas and showed the landscaping cover around the climbing dome and climbing equipment and did not meet the six inch requirement. Violation confirmed corrected by letter recei
