Across 2 inspections since 2025, the issues cited most often were Electrical Outlets and Power Strips, Not in Use, Which Were Located in Space Used by Children Did Not Have Safety Outlets or Were Not Covered with Safety Plugs... (1), Plastic Bags, Materials That Could Be Torn Apart and Toy Parts Small Enough to Be Swallowed Were Accessible to Children Under Three Years of Age. (1), and A Violation Was Found for Which There Is No Item Number. (1). None of the 5 findings were critical.

Plastic bags were located less than 5 feet up. Violation corrected during visit
