(1), and All Staff Did Not Successfully Complete Certification in First Aid Appropriate to the Age of Children in Care. (1). None of the 5 findings were critical.

● **Fire Drills Were Not Practiced Monthly And/or the Drill Record Was Incomplete.**

The facility has not had a fire drill since 8/29/25. Violation confirmed corrected by letter received from provider on 11/12/2025

● **All Staff Did Not Successfully Complete Certification in First Aid Appropriate to the Age of Children in Care.**

Verification of staff completion of First Aid training from an approved training organization was not in the staff file. Two staff members did not have verification of an app

● **All Staff Did Not Successfully Complete Certification in CPR Training Appropriate to the Age of the Children in Care.**

Verification of staff completion of the CPR course from an approved training organization was not in the staff file. Two staff did not have an approved CPR class. Viol
