Across 3 inspections since 2025, the issues cited most often were New Staff, Who Had Contact with Children, Did Not Receive at Least 16 Hrs. Orientation Within First 6 Weeks. (1), Health and Safety Training Topics Were Not Included as Part of On-going Training Within Five Years of Completing the Previous Health and Safety Training Topics. (1), and Operator Has Not Scheduled and Obtained a Fire Inspection Within 12 Months of the Previous Inspection. (1). None of the 5 findings were critical.

● **New Staff, Who Had Contact with Children, Did Not Receive at Least 16 Hrs. Orientation Within First 6 Weeks.**

Documentation of receiving orientation in all the required topics was missing from 5 staff files. Violation confirmed corrected by letter received from provider on 2/24/2026

● **Health and Safety Training Topics Were Not Included as Part of On-going Training Within Five Years of Completing the Previous Health and Safety Training Topics.**

Several staff members did not complete training in the required topics within their first year of employment. Violation confirmed

Mar 20, 2025 2 Findings ● 2 Important

● **Operator Has Not Scheduled and Obtained a Fire Inspection Within 12 Months of the Previous Inspection.**

Operator did not submit the original approved report to DCDEE within one week of the inspection visit on a form provided by the Division. The last documented fire inspection was completed

● **Shelter-in-place or Lockdown Drills Were Not Practiced Every Three Months And/or Drill Record Was Incomplete.**

The last documented emergency drill was completed 9/26/24. Violation confirmed corrected by letter received from provider on 3/25/2025
