The outdoor swing set was not anchored. Violation confirmed corrected by letter received from provider on 5/23/2024

● **Hazardous Cleaning Supplies and Other Items That Might Be Poisonous E.g. Toxic Plants, Were Not Out of Reach or in Locked Storage When Children Were in Care.**

Poison ivy was located on the playground and needs to be removed. Violation confirmed corrected by letter received from provide

● **For Off-premise Activities Occurring on Regular Basis, the Standing Permission for 12 Months Had Expired.**

Four(4) erolled children had an expired off-premise permission. Violation confirmed corrected by letter received from provider on 5/23/2024
