There are currently three infants enrolled at this child care center. The cribs were not individually identified/assigned with each child's name. Violation confirmed corrected by letter received from provide

● **Medications Including Prescription and Non-prescription Items Were Not Stored in a Locked Cabinet or Other Locked Container.**

One over the counter diaper cream was found in an unlocked cabinet under the changing table which was accessible to the children. Violation confirmed corrected

● **A Drug or Medication Was Administered Without Written Authorization And/or Instructions From a Child's Parent or Authorized Health Professional.**

A diaper cream in the infant room was not accompanied by the required parent authorization form. Violation confirmed corrected by letter rec

● **New Staff, Who Had Contact with Children, Did Not Receive at Least 16 Hrs. Orientation Within First 6 Weeks.**

Two staff members (T.A. & K.M.) did not have proof of completing the required Orientation within the first six week of employment. Violation confirmed corrected by letter recei
